About Navarupantar Home

Navarupantar Home for Special Need Children is opened in December 6, 2022. It provides shelter for underprivileged, orphaned, and semi-orphaned children aged between 6-18 years. The begining in the home was made with four children. It is now houses 10 children and has the total capacity for 25. Support provided in the home include food, clothing, education, medical care. The home is located at Rupaisiding, Kako Road, Doomdooma, Tinsukia district of Assam. The place is approximately 500 km from the state capital and 30 km from Tinsukia township, the district headquarter.

With utmost care and empathy, it provides physical, moral, and psychological assistance to children with disabilities to help them join mainstream society. Operating under the Juvenile Justice Act, children are referred by the Child Welfare Committee (CWC), Tinsukia. Navarupantar aims to be a safe and nurturing home where these vulnerable children can thrive.

Objectives

- To rehabilitate children in need of care and protection for their care, treatment, education, training, development and rehabilitation.
- To provide them basic education and welfare services like free lodging, boarding, health and recreation.
- To combat stereotypes, prejudices and harmful practices relating to Person with disabilities (PwD)

- Observation during field visits that Divyangjans are deprived of basic entitlements.
- Public Complaints on lack of timebound Disability Certificates and UDID Card services.
- Lack of Convergence: Health, Social Justice & other departments.
- Ad Hoc Medical Board for obtaining Disability Certificate: Orthopedic Surgeon issue.
- Non existance of any database of Divyangian.
- No institution to act as their voice.


Implementation Strategies

- **House to House Survey** (H2H Survey) : Anganwadi Workers conducted a H2H Survey to identify all Divyangjans in the district by filling up a Survey format comprising vital information.
- Three Tier Organization Structure: Divyang Bandhu assisted by Anganwadi Workers, Block Level Committee headed by CDPOs, District Level Committee headed by District Collector.
- **Divyang Bandhu:** An institution to voice out the needs of Divyangjans at the grassroot level.
- **Disability Certificate for All:** Through decentralized Disability Camps, permanent Medical Board, Shop Floor arrangement, Free & Easy Transportation, Digital process.
- **UDID Card for All**: A dedicated Data Team, digitization of all data of the Survey and Disability Camps, free application at UDID portal.
- **District Divyangjan Atlas:** A portal to ensure real-time montoring and ease of applications.
- Aids, Appliances and Prosthetics: Assessment camps in association with ALIMCO and NILD followed by delivery of aids and fitting.
- **Divyangjan Skilling:** One Batch of 34 Divyangjan has completed Bamboo Craft Training. 12 out of which, have been employed recently
- **Divyangjan Voter Enrolment:** Voter Enrolment done at doorsteps by filling up of Form 6, also PWD marking in Electoral Roll is done to facilitate the home voting through Postal Ballot by Divyangjans.
- **Training Module:** Experts from non-govt sectors, trained the Govt. officials on issues related to disabilities through a proctored training module.
- Scheme enrolment and Inclusion: Coverage of Divyangjan under Ration Card, Orunodoi and PMAY underway currently. Aadhaar on Wheels for Aadhaar enrolment at Doorsteps.
- Feedback & Grievance Module: A Toll-free number has been notified for all grievances under "Thoughtful Tinsukia". Also, a feedback form has been designed in which the beneficiaries may note their experience.



About Tinsukia District

Tinsukia is the easternmost district of Assam in India. Located, around 480km from Guwahati the capital city of the state. Tinsukia is known for its cultural richness, natural beauty, and economic significance. However, when it comes to the question of disability there is found to be a considerable gap in ensuring inclusivity to such individuals. Nestled amidst the emerald embrace of Assam's Tinsukia district, lie the tea gardens, verdant havens humming with the tireless labor of their communities. Study on the educational status of migrant labour in five zones of India

Objectives

- To analyse the phenomenon of labour migration in terms of concentration/pockets, nature, reason and trend.
- To analyse source cities/districts of labour migration as well as destination cities/districts among the five zones of the country, i.e., North, South, East, West and North East Zone.
- Identify MLs with and without accompanying children at the place of destination and examine their nature, stream, sector and factors influencing of migration.
- To examine the educational status of the accompanying and left behind children of MLs at the destination as well assource cities/districts in the context of RTE Act, 2009.
- Analyse the factors influencing educational status of children of MLs and the impact of Covid-19.
- Draw good practices encouraging improvement of the educational status of MLs.
- Recommend suggestion for improvement of the educational status of the children of MLs.

Major Findings

- 1. The west zone shows good percentage of enrollment in both source and destination whereas in other zones it is concerned and all zoneat the same time exihibit the least percentage of dropout and never enrolled children
- 2.Lack of state policies provision to support the RTE Act and lack of budget for awareness programmes at the local level.
- 3.In the states of Maharashtra and Karnataka, the departments of education take steps to enroll the children of the MLs in government schools by providing bridge courses by reducing the document requirements.
- 4.Lack of any tracing or tracking mechanism for migrant labourers and their children, which has led to a complete lack of documentation with regard to the educational status of the children.
- 5. The state governments, generally, do not have any policies in place for allowing the flow of financial support that can help the local bodies facilitate free and compulsory education for children of migrant labourers.



Recommendation

- The states/UTs need to enact at least one all-encompassing policy for children of migrant labours which can support the RTE Act in ensuring free and compulsory education for the deprived children.
- The policy on children of migrant labours must have specific budgetary provisions for tracing/tracking of MLs and their children, awareness programmes among parents as well as through mass media such as print, tv and radio.
- Common curriculum schemes in different language is needed for enabling the children of migrant labours coming from other state.
- A flexible scheme/policy is needed on the documents allowing easy enrolment of the children of migrant labours in schools.
- Special provision may be introduced for regular survey for identification and for issuing identity cards for ensuring easy school enrolment of the children of migrant labours.
- Awareness generation should be made a mandatory function of school authorities and the institutions of local government for successful implementation of the Right to Education Act 2009.
- Policy of free boarding to the children of migrant labours may be introduced for ensuring the provision of Right to Education Act 2009.




