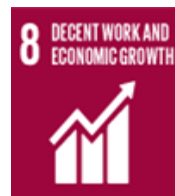

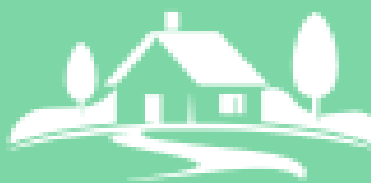

- The diseases recorded are birth defect, severe malnutrition, skin disease, heart disease etc.

Achievements (2016-19)



Eliminating Measles & Control Congenital Rubella Syndrome Sep-Dec'18

Facilitation Partners: Health & Family Welfare Department, FISS, UNICEF, Panchayat and village Community.

Beneficiaries: Children from nine months to fifteen years of age.

FISS has covered five hundred and forty schools of Assam reaching two lakh seventeen thousand and two hundred students



FISS strived to eradicate Measles & Control Congenital Rubella from the society. This was achieved to a greater extent by way of organizing awareness programs, participatory programme among development sector partners, volunteers and community stakeholders, providing free or affordable vaccination and/or medicines. It has also endorsed MR vaccine which will be introduced as Measles-Rubella vaccination campaign by Government of India.

State Level Consultation for Adolescent Programming in Assam under Rashtriya Kishore Swasthya Karyakram, 1st Mar'19

Venue: Guwahati.

Facilitation Partners: FISS, ASCPCR and NHM.

Technical partner- UNICEF

Beneficiaries: Adolescents children aging 10-19 years

The focus of this conference was on five components viz. Health, Nutrition, WASH, Child Protection and Adolescent. A Panel of eight experts addressed the conference and had interaction sessions to answer queries. The other major concern areas discussed during the session were child protection, child trafficking, abuse, etc. so that a concrete action plan can be designed and defined to ensure better adolescent health of boys and girls.

FISS has proposed to implement the lab district scheme under RKSK in the Dhubri District of Assam.



Status of Drop-out Rate in North Eastern States and Devising Pathways for addressing High Drop Out in Region, 25-26th Mar'19

Venue: Administrative Staff College, Guwahati.

Facilitation Partners: NCPCR in collaboration with FISS, ASCPCR

Beneficiaries: Drop out children

The conference primarily focused on drop outs in Assam and other north east states of India. The speakers were esteemed and knowledgeable guests from different states of North East.

The participants were made aware of the provision of Article 21 of Indian Constitution that is free and compulsory education under RTE or Sarva Shiksha Abhiyan.

The consultation programme also highlighted on addiction, abuse and other anti-social elements increasing in the vicinity of growing children. An emphasis was also

given on significance of vocational training and other skill development interventions from school level. In addition, panel discussion was also held on Situational Analysis of drop-outs rate among children in North Eastern States.

After brain storming and intense interactive sessions an action plan was tentatively outlined as per the need of the respective schools.

Aligned with SDG 4, the participants were educated on Article 21 of Indian Constitution about free and compulsory education under RTE or Sarva Shiksha Abhiyan.



State Level Consultation on Drug and Substance Use among children, 20th Mar'19

Beneficiaries:

Children and Adolescents who are vulnerable to addiction and exploitation.

Alcohol and other drug use have posed a serious threat to the health of children and adolescents. In this regard, FISS had organized a consultation programme with various dignitaries to spread awareness on prevention and identifying addiction at an early stage, community participation and emotional quotients of children prone to or vulnerable to addiction.

Recommendations

- Need of more rehabilitation centers
- Doctors and counselors are required at every school cluster
- Enforcement of stringent laws and strict legal actions to ban the sale of drugs or alcohol to under-age children.
- Convergence of the entire line department in the eight states of Northeast working in the field of drug and substance use among children to identify and overcome the existing loopholes.



Leveraging HAAT Platform for OGA on Demand Generation of OCPs with Married Women, Feb 23-24, 2019

The event was a part of the We 4 women initiative that aimed to spread awareness on family planning methods like use of OCPs (Oral contraceptive pill) among the married couples and to take medical guidance for better sexual life and bear child as and when desired. In addition, subsidized OCPs were also given to the pharmacists to be distributed among the women.

Implementation of the provisions of Rights of Children to Free and Compulsory Education (RTE) Act, 2009 in 400 schools

Aim -To check whether the provisions of Rights of Children to Free and Compulsory Education (RTE) Act, 2009 for enabling positive learning environment is associated with overall growth and development, cognitive behaviour and most importantly, safety and security of a child.

Districts Covered -Charaideu, Lakhimpur, Dhemaji, Baksa & Udalguri

The major factors which are being identified for the survey are likely pupil-teacher ratio, infrastructure, health and hygiene and training provided to SMCs.

Assam State Commission for Protection of Child Rights (SCPCR) had engaged Foundation for Integrated Support and Solution (FISS), Guwahati to conduct a survey on 400 numbers of schools identified by SCPCR in the districts (Charaideu, Lakhimpur, Dhemaji, Baksa & Udalguri) with regard to on implementation of the provisions of Rights of Children to Free and Compulsory Education (RTE) Act, 2009. The major factors which are being identified for the survey are likely pupil teacher ratio, infrastructure, health and hygiene and training provided to SMC's.

FISS was also assigned to do data analysis and generation of report of 1500 number of schools as per the list provided by SCPCR, Assam on the above mentioned subject.

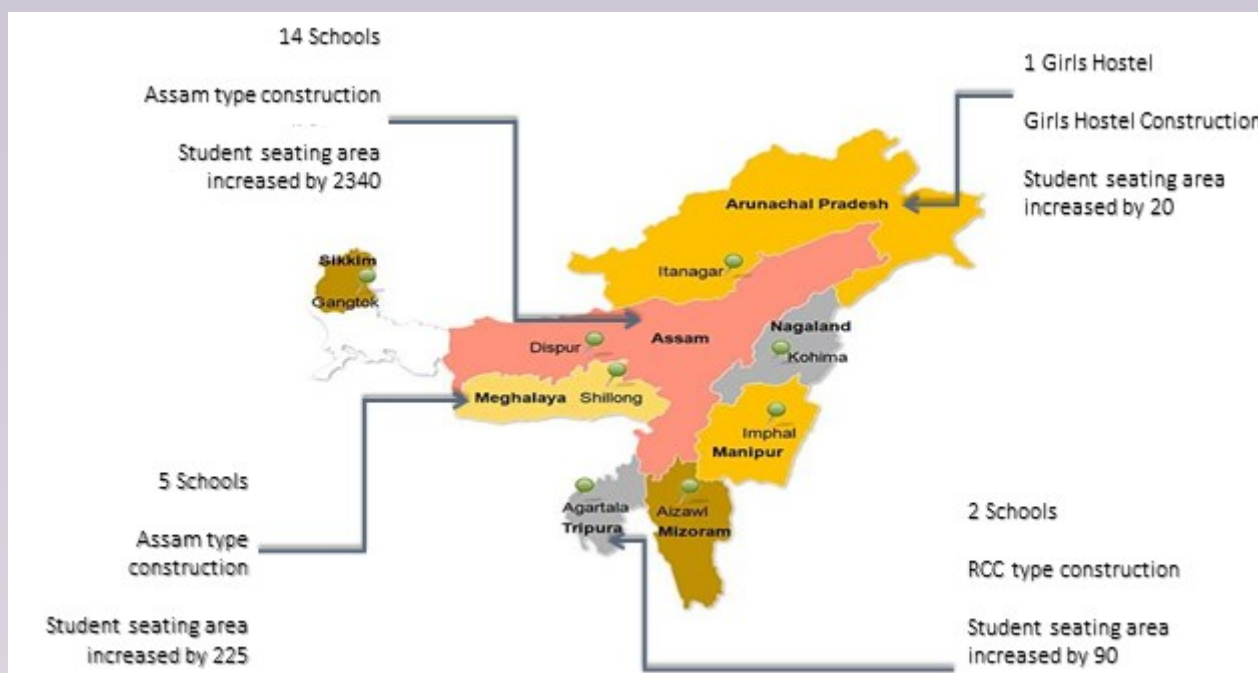

Installation of Solar powered water purifier system in schools

This project was carried out with a view to provide daily provision of child-friendly and sustainable safe drinking water.

The project intends to install solar water purifier (RO) for the selected schools.

- Daily provision of child-friendly and sustainable safe drinking water and adequate water for hand washing.
- Water for school cleaning and also food preparation and cooking.

FISS will try to align along with such likeminded NGOs and guide them in implementing as well as monitoring such project.
